Student - Free

- * A Natick resident who is enrolled in a public or private school
- * under the age of eighteen
- * granted use of the Natick Pegasus studio and edit suites
- * A legal guardian or school Instructor must sign out equipment
- * Guardian must have membership
- * **Member must present student ID card**

Affiliate - \$20.00

- * a Natick resident that is eighteen years of age or older
- * granted use of the Natick Pegasus Public Access channels only
- * for the sole purpose of submitting outside programming for broadcast
- * **you are not entitled to the use of the studio, edit suites or equipment**

Individual "P"- \$35.00 (Non-Business) Access production Only

- * a Natick resident that is eighteen years of age or older
- * granted use of the Natick Pegasus studio, edit suites and equipment
- * **individual "P" members may only participate in access production located on private property at private not (not Public) events**

Individual "PEG"- \$35.00 (Non-Business) All productions

- * a Natick resident that is eighteen years of age or older
- * granted use of the Natick Pegasus studio, edit suites and equipment
- * **individual "PEG" members may participate in access, education and government production located on public and private property**
- * **individual "PEG" members must submit to and pass a CORI/SORI check before their membership is valid**

Business "P"- \$100.00

- * a Natick-based organization or representative of a Natick business
- * one principal member and up to three alternate members
- * principal member accepts responsibility for the group
- * granted use of the Natick Pegasus studio edit suites and equipment
- * alternate members may use the facilities and equipment but only under the signature of the principal member
- * only the principal member can add or exchange alternate members
- * additional alternate members can be added for a fee
- * **business "P" members may only participate in access production located on private property at private not (not public) events**
